- **Applications:** All applications will be processed on a first-come first serve basis & will be accepted no later than **Friday, April 18, 2008**. Please return completed application with cashier's check or money order and applicable forms to the American GI Forum, 765 Story Road, Suite 150, San Jose, CA 95122. Cash accepted in person only, credit card payments (Visa, Master Card) acceptable by phone. No personal checks accepted **NO REFUNDS**.
- **Booth Guidelines:** All booths must open by 10:00A.M and close promptly at 6:00 P.M. Set-Up will not be allowed after 9:00A.M. All vendors are strictly prohibited from selling beverages of any kind. No items may be distributed or sold without the written consent of San Jose GI Forum. **FINAL BOOTH LOCATION TO BE DETERMINED BY FORUM COMMITTEE.**
- **The Following Items are Not Provided:** Water, Tables, Chairs, and Garbage Cans. You can submit an electrical application request, which will be submitted to the City of San Jose. We will provide electricity on a limited basis for a fee of \$75.00.
- **The American GI Forum Will Supply the Space and Canopy (10X10 feet) ONLY.** Additional space is sold in 10X10 feet increments only. Booth spaces are the same price with or without canopy.
- **The San Jose Fire Department and The Santa Clara County Health Department Require:** All food vendors attend a mandatory meeting at the San Jose GI Forum, 765 Story Road, Suite 150, San Jose. The San Jose Fire Department does not permit gasoline generators in the festival area and prohibits parking vehicles next to booths. A currently dated 2A: 10B:C. fire extinguisher, when deep-fat frying fire extinguisher 40:BC is required.
- **Health Permit** All booths serving/sampling food requires a temporary health permit from the Santa Clara County Department of Environmental Health. **HEALTH PERMIT APPLICATIONS DUE WEDNESDAY, APRIL 16, 2008. NO EXCEPTIONS!!**
- **Violations of Rules:** Any product or service not listed voids agreement without refund. Any violation of these rules may cause the closure of your booth and prevent future participation. The American GI Forum does not guarantee or imply profit to any vendor. Further, **The San Jose GI Forum reserves the right to change festival site plans without notice.**
